The ENABLING "**Biomass Matrix Tool**" will be developed to help the user in evaluating the **potential and available biomass** and industrial processes, considering the different bioproducts pathways.



The **Enabling coaching service**, available through an **online interface** provided via the website, to **support biomass producers** or the **BBP industry** for the uptake of emerging best practices.



The ENABLING project will develop a **permanent innovation brokerage platform (BIOMASS TRADE)** likely to become in the future, one of the main **marketplaces** and innovation transfer accelerators at European level.
